In Kentucky a State Transportation Innovation Council (STIC) has been developed to bring together stakeholders that represent market forces and to work together to lead innovation.

Purpose

This Charter establishes the State Transportation Innovation Council (STIC) and defines its mission and scope. The members of the STIC are also provided.

Vision

The State Transportation Innovation Council (STIC) has identified EDC initiatives and will foster a collaborative culture for rapid and effective implementation.

Mission

The STIC will facilitate the rapid knowledge sharing and implementation of adopted technology initiatives. The STIC will share experiences with professionals, all levels of state government, and throughout the private and non-profit sector to ensure smart, efficient investment in their State's highway infrastructure.

Scope and Responsibility

The STIC can bring together stakeholders that represent market forces and work together to lead innovation in the state transportation program.

The STIC includes multi-stakeholder leadership to perpetuate the development and deployment of innovation.

The objectives and duties of the STIC include identification of technology initiatives which are highly likely to be successfully implemented within Kentucky. The STICs will act as a catalyst for rapid deployment.
