Objective of the State Transportation Innovation Council

The STIC provides multi-stakeholder leadership to perpetuate the deployment of innovation. As a representative body of transportation stakeholders in Massachusetts, the STIC is the forum for initiating and overseeing the process of deploying and institutionalizing innovative strategies and technologies to accelerate transportation project delivery and enhance project quality and effectiveness. The STIC acts as a catalyst for technologies, techniques, and tactics that have been demonstrated in "real world" applications and can offer improved performance/effectiveness in their state.

STIC Member Responsibilities

STIC Members provide input on the initiatives to be pursued, appoint agency and industry representatives to the implementation teams, and establish performance goals to measure success. STIC decisions are by agreement of all participating members subject to the concurrence of the MassDOT and FHWA co-chairs.

Meeting Schedule

The STIC meets on a quarterly basis. The STIC will disband only upon agreement of the two cochairs.

Resources

Staff support for the STIC will be provided by both the MassDOT and FHWA EDC Coordinators. Funding for travel for the STIC and the implementation teams may be available from FHWA.

STIC Membership

The STIC is comprised of representatives of MassDOT, FHWA, other state transportation agencies, state resource agencies, state-sponsored technical assistance programs, metropolitan planning organizations, municipalities, transportation consultants, the transportation construction industry, and federal resource agencies, as shown on the attached table. The STIC is jointly chaired by the MassDOT Highway Administrator and the FHWA Massachusetts Division Administrator.
