(1) - With the exception of the set-aside amounts for Alaska, New Jersey and Washington for the NHS, all FY2005 available FBD funds were designated for specific projects by Congress in the conference report accompanying the FY2005 Transportation Appropriations Act (Division H of Public Law 108-447).

(2) - SAFETEA-LU authorized \$38 million for FBD for FY 2005. After the takedown of 14.5% for obligation limitation lop-off and the required \$20 million set-aside in 23 U.S.C. 147(d) for Alaska (\$10 million), New Jersey (\$5 million) and Washington (\$5 million), \$12,490,000 is available for these designated projects.

(3) - These set-aside amounts for Alaska, New Jersey, and Washington are required under the provisions of 23 U.S.C. 147(d).

(4) - The funds for this project have been allotted to the Federal Lands Highways Office, at the request of the State.
