1/ This table shows Federal Highway Administration estimates of gasohol use. The Energy Policy Act of 1992 expanded the definition of gasohol effective January 1, 1993. Under the Act, three types of gasohol were defined: (1) 10-percent gasohol, (2) 7.7-percent gasohol, which contains at least 7.7 percent alcohol but less than 10 percent; and (3) 5.7-percent gasohol which contains at least 5.7 percent alcohol but less than 7.7 percent. Due to data and estimation limitations, the table displays all levels of gasohol as one number.

2/ The amount of ethanol used in gasohol is estimated from gasohol tax collections, refunds, and credits reported by the Internal Revenue Service, U.S. Department of the Treasury.

3/ States formatted in bold are fully or partially estimated, other figures are gasohol as reported by the State.
