## Notes on SEP-14 tracking list spreadsheet:

On April 24, 2012, FHWA accepted NYSDOT proposed 3 year work-plan for the use of Best-Value(BV) selection of design-bid-build (DBB) construction contracts through the Federal "Alternative Contracting" SEP.14 program. As part of the work-plan, 4 different types of reports will be provided to FHWA which are explained below. At a minimum, all reports will address three key primary measures, cost-savings, time and quality. This spreadsheet is intended to keep record of when reports are due and when they have been accepted by FHWA.

The work-plan requires 4 different types of reports:

- 1.) Interim project reports To be provided 3 months after the project has been awarded to provided detail on how BV was utilized as part of the selection process.
- 2.) Final project reports To be provided 6 months after the project is completed. The report will provide detail on the results of using BV.
- 3.) Annual reports These reports cover from 5/1 to 4/30 and allow 3 weeks to finish and send to FHWA. The reports provide an overall summary of the use of BV for the past year.
- 4.) Final Program Report This report is due 6 months after completion of the last BV project.
