
<u>Draft Ports Primer for Communities: An Overview of Ports</u> <u>Planning and Operations to Support Community Participation</u>

Designed to inform the port industry sector of the perspectives, priorities, and challenges often unique to communities with EJ concerns.



Port NOLA properties include a diverse portfolio of sites on the Mississippi River, Gulf Intracoastal Waterway and Inner Harbor Navigation Canal.






PORT OF NEW ORLEANS OUR CONNECTIONS RUN DEEP
