Subject: Request for Waiver to "Buy America" 23CFR 635.410

NCDOT is requesting a waiver to the "Buy America" requirements in order to purchase two (2) VOITH Turbo 16 GII/100 propulsion units for the reference project. The federal regulations part 23CFR 635.410 allows a state to request a waiver from the requirement is there are no products available to meet the specification of this product. The NCDOT Ferry Division has purchased seven (7) ferries with similar units, some using Federal matching funds to build the vessels.

The vessel will be used for passenger/vehicle service on the Outer Banks of North Carolina. The ferry will help provide additional capacity to move traffic along a very important and strategic route between Ocracoke Island and Hatteras. The ferry will be replacing an older Hatteras Class ferry with lesser capacity and maneuverability. This River Class design ferry will provide a safer and more cost effective means for moving traffic. The current route is approximately 12 miles in length in an area with higher than average winds and shallow water conditions.

The new vessel will join a fleet of other River Class ferries involved with strategic transportation needs in this area of North Carolina. We are building this ferry to better put our fleet in a position to use standardized type vessels to meet the changing demands of transportation along the Outer Banks. This will be our eighth VOITH Turbo equipped ferry allowing us to train and equip our crews with the latest technology and equipment available.

The cost of the propulsion system is similar to past units purchased and will use similar spare parts for repairs and maintenance. These units provide superior maneuverability compared to standard propeller and rudder installations. A vessel equipped with these units can provide a very safe environment for passengers and vehicles. We have operated similar units for more than 20 years on the Outer Banks, Southport, Cherry Branch and Pamlico River in North Carolina.

We therefore request approval of a waiver from the "Buy America" requirement for this partially FHWA funded project.
