# STEWARDSHIP AND OVERSIGHT AGREEMENT ON PROJECT ASSUMPTION AND PROGRAM OVERSIGHT BY AND BETWEEN

# FEDERAL HIGHWAY ADMINISTRATION, SOUTH DAKOTA DIVISION AND THE

#### SOUTH DAKOTA DEPARTMENT OF TRANSPORTATION

#### SECTION I. BACKGROUND AND INTRODUCTION

The Federal-aid Highway Program (FAHP) is a federally-assisted program of State-selected projects. The Federal Highway Administration (FHWA) and the State Departments of Transportation have long worked as partners to deliver the FAHP in accordance with Federal requirements. In enacting 23 U.S.C. 106(c), as amended, Congress recognized the need to give the States more authority to carry out project responsibilities traditionally handled by FHWA. Congress also recognized the importance of a risk-based approach to FHWA oversight of the FAHP, establishing requirements in 23 U.S.C. 106(g). This Stewardship and Oversight (S&O) Agreement sets forth the agreement between the FHWA and the South Dakota Department of Transportation (SDDOT) on the roles and responsibilities of the FHWA and the SDDOT with respect to Title 23 project approvals and related responsibilities, and FAHP oversight activities.

The scope of FHWA responsibilities, and the legal authority for SDDOT assumption of FHWA responsibilities, developed over time. The U.S. Secretary of Transportation delegated responsibility to the Administrator of the FHWA for the FAHP under Title 23 of the United States Code, and associated laws (49 CFR 1.84 and 1.85). The following legislation further outlines FHWA's responsibilities:

- Intermodal Surface Transportation Efficiency Act (ISTEA) of 1991;
- Transportation Equity Act for the 21st Century (TEA-21) of 1998;
- Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) of 2005; and
- Moving Ahead for Progress in the 21st Century Act (MAP-21) of 2012 (P.L. 112-141).

The FHWA may not assign or delegate its decision-making authority to a State Department of Transportation unless authorized by law. Section 106 of Title 23, United States Code (Section 106), authorizes the State to assume specific project approvals. For projects that receive funding under Title 23, U.S.C., and are on the National Highway System (NHS) including projects on the Interstate System, the State may assume the responsibilities of the Secretary of the U.S. Department of Transportation under Title 23 for design, plans, specifications, estimates, contract awards, and inspections with respect to the projects unless the Secretary determines that the assumption is not appropriate (23)

U.S.C. 106(c)(1), in accordance with Section III. For projects under Title 23, U.S.C. that are not on the NHS, the SDDOT shall assume the responsibilities for design, plans, specifications, estimates, contract awards, and inspections unless the State determines that such assumption is not appropriate (23 U.S.C. 106(c)(2), in accordance with Section IV.

For all other project activities which do not fall within the specific project approvals listed in Section 106 or are not otherwise authorized by law, the FHWA may authorize SDDOT to perform work needed to reach the FHWA decision point, or to implement FHWA's decision. However, such decisions themselves are reserved to FHWA.

The authority given to the SDDOT in accordance with Section III and IV under Section 106(c)(1) and (2) is limited to specific project approvals listed herein. Nothing listed herein is intended to include assumption of FHWA's decision-making authority regarding Title 23, U.S.C. eligibility or Federal-aid participation determinations. The FHWA always must make the final eligibility and participation decisions for the Federal-aid Highway Program.

Section 106(c)(3) requires FHWA and the SDDOT to enter into an agreement relating to the extent to which the SDDOT assumes project responsibilities. This Stewardship and Oversight Agreement (S&O Agreement), includes information on specific project approvals and related responsibilities, and provides the requirements for FHWA oversight of the FAHP (Oversight Program), as required by 23 U.S.C. 106(g).

#### SECTION II. INTENT AND PURPOSE OF S&O AGREEMENT

The intent and purpose of this S&O Agreement is to document the roles and responsibilities of the FHWA's South Dakota Division Office (FHWA or Division) and SDDOT with respect to project approvals and related responsibilities, and to document the methods of oversight which will be used to efficiently and effectively deliver the FAHP.

The Project Action Responsibility Matrix, Appendix B to this S&O Agreement and as further described in Section VIII of this S&O Agreement, identifies FHWA FAHP project approvals and related responsibilities SDDOT assumes from FHWA on a program-wide basis pursuant to 23 U.S.C. 106(c) and other legal authorities. Upon execution of this agreement, Appendix B shall be controlling and except as specifically noted in Appendix B, no other agreements, attachments, or other documents shall have the effect of delegating or assigning FHWA approvals to SDDOT on a program-wide basis under 23 U.S.C 106 or have the effect of altering Appendix B.

## SECTION III. ASSUMPTION OF RESPONSIBILITIES FOR FEDERAL-AID PROJECTS ON THE NATIONAL HIGHWAY SYSTEM

- A. The SDDOT *may assume* the FHWA's Title 23 responsibilities for design; plans, specifications, and estimates (PS&E); contract awards; and inspections, with respect to *Federal-aid projects on the National Highway System (NHS)* if both the *SDDOT* and *FHWA* determine that assumption of responsibilities is appropriate.
- B. Approvals and related activities for which the SDDOT has assumed responsibilities as shown in Appendix B will apply program wide unless project specific actions for which the Division will carry out the approval or related

- responsibilities are documented in accordance with the FHWA Project of Division Interest/Project of Corporate Interest Guide (FHWA PoDI/PoCI Guide) located at: <a href="http://www.fhwa.dot.gov/federalaid/stewardship">http://www.fhwa.dot.gov/federalaid/stewardship</a>
- C. The SDDOT may not assume responsibilities for Interstate projects that are in high risk categories as defined in Section IX. (23 U.S.C. 106(c)(1))
- D. The SDDOT is to exercise any and all roles of the Secretary's responsibilities for Federal-aid projects on the NHS in accordance with Federal laws, regulations and policies, as identified in Appendix B.

# SECTION IV. ASSUMPTION OF RESPONSIBILITIES FOR FEDERAL-AID PROJECTS OFF THE NATIONAL HIGHWAY SYSTEM

- A. The SDDOT *shall assume* the FHWA's Title 23 responsibilities for design, PS&Es, contract awards, and inspections, with respect to *Federal-aid projects off the NHS (non-NHS)*, as identified in Appendix B, unless the *SDDOT* determines that assumption of responsibilities is not appropriate. (23 U.S.C. 106(c)(2))
- B. Except as provided in 23 U.S.C.109(o), the SDDOT is to exercise the Secretary's approvals and related responsibilities on these projects in accordance with Federal laws.
- C. The SDDOT, in its discretion, may request FHWA carry out one or more non-NHS approvals or related responsibilities listed as "State" in Appendix B on a program-wide basis. For a project specific request, the State may request FHWA carry out any approval or related responsibility listed in Appendix B off the NHS. Such project-specific requests shall be documented in accordance with the FHWA PoDI/PoCI Guide.
- D. Pursuant to 23 U.S.C. 109(o), non-NHS projects shall be designed and constructed in accordance with State laws, regulations, directives, safety standards, design standards, and construction standards.

# SECTION V. ASSUMPTION OF RESPONSIBILITIES FOR LOCALLY ADMINISTERED PROJECTS

The SDDOT may permit local public agencies (LPAs) to carry out the SDDOT's assumed responsibilities on locally administered projects. The SDDOT is responsible and accountable for LPA compliance with all applicable Federal laws and requirements.

# SECTION VI. PERMISSIBLE AREAS OF ASSUMPTION UNDER 23 U.S.C. 106(c)

SDDOT assumption of responsibilities under 23 U.S.C. 106(c) may cover only activities in the following areas:

- A. Design, which includes preliminary engineering, engineering, and design-related services directly relating to the construction of a FAHP-funded project, including engineering, design, project development and management, construction project management and inspection, surveying, mapping (including the establishment of temporary and permanent geodetic control in accordance with specifications of the National Oceanic and Atmospheric Administration), and architectural-related services.
- B. PS&E, which represents the actions and approvals required before authorization of construction. The PS&E package includes geometric standards, drawings, specifications, project estimates, and certifications relating to completion of right-of-way acquisition and relocation, utility work, and railroad work.
- C. Contract awards, which include procurement of professional and other consultant services and construction-related services to include advertising, evaluating, and awarding contracts.
- D. Inspections, which include general contract administration, material testing and quality assurance, review, and inspections of Federal-aid contracts as well as final inspection/acceptance.
- E. Approvals and related responsibilities affecting real property as provided in 23 CFR 710.201(i) and any successor regulation in 23 CFR Part 710.

# SECTION VII. FEDERAL APPROVALS AND RELATED RESPONSIBILITIES THAT MAY NOT BE ASSUMED BY THE SDDOT

- A. Any approval or related responsibility not listed in Appendix B cannot be assumed by the State without prior concurrence by FHWA Headquarters. The following is a list of the most frequently-occurring approvals and related responsibilities that may not be assumed by the SDDOT:
  - Civil Rights Program approvals;
  - Environmental approvals, except those specifically assumed under other agreements. (23 U.S.C. 326 and 327; programmatic categorical exclusion agreements);
  - Federal air quality conformity determinations required by the Clean Air Act;
  - Approval of current bill and final vouchers;
  - Approval of federally-funded hardship acquisition, protective buying, and 23 U.S.C. 108(d) early acquisition;
  - Project agreements, modifications to project agreements, and obligation of funds (including advance construction);
  - Planning and programming pursuant to 23 U.S.C. 134 and 135;
  - Special Experimental Projects (SEP-14 and SEP-15);
  - Use of Interstate airspace for non-highway-related purposes;
  - Any Federal agency approval or determination under the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 (Uniform Act), as amended, and implementing regulations in 49 CFR Part 24;
  - Waivers to Buy America requirements;
  - Approval of Federal participation under 23 CFR 1.9(b);

- Provide pre-approval for preventive maintenance (preservation eligible) projects (until FHWA concurs with SDDOT procedures or activity);
- Requests for credits toward the non-Federal share of construction costs for early acquisitions, donations, or other contributions applied to a project;
- Functional replacement of property;
- Approval of a time extension for preliminary engineering projects beyond the 10-year limit, in the event that actual construction or acquisition of right-of-way for a highway project has not commenced;
- Approval of a time extension beyond the 20-year limit for right of way projects, in the event that actual construction of a road on the right-of-way is not undertaken:
- Determine need for Coast Guard Permit;
- Training Special Provision Approval of New Project Training Programs; and
- Any other approval or activity not specifically identified in Appendix B, unless otherwise approved by the FHWA, including the Office of Chief Counsel.
- B. For all projects and programs, the SDDOT will comply with Title 23 and all applicable non-Title 23, U.S.C. Federal-aid program requirements, such as metropolitan and statewide planning; environment; procurement of engineering and design related service contracts (except as provided in 23 U.S.C. 109(o)); Civil Rights including Title VI of the *Civil Rights Act*, and participation by Disadvantaged Business Enterprises; prevailing wage rates; and acquisition of right-of-way, etc.
- C. This Agreement does not modify the FHWA's non-Title 23 program approval and related responsibilities, such as approvals required under the Clean Air Act; National Environmental Policy Act, Executive Order on Environmental Justice (E.O. 12898), and other related environmental laws and statutes; the Uniform Act; and the Civil Rights Act of 1964 and related statutes.

#### SECTION VIII. PROJECT ACTION RESPONSIBILITY MATRIX

Appendix B, Project Action Responsibility Matrix, to this S&O Agreement identifies FAHP project approvals and related responsibilities. The Matrix specifies which approvals and related responsibilities are assumed by the State under 23 U.S.C. 106(c) or other statutory or regulatory authority, as well as approvals and related responsibilities reserved to FHWA.

#### SECTION IX. HIGH RISK CATEGORIES

A. In 23 U.S.C. 106(c), Congress directs that the Secretary shall not assign any approvals or related responsibilities for projects on the Interstate System if the Secretary determines the project to be in a high risk category. Under 23 U.S.C. 106(c)(4)(B), the Secretary may define high risk categories on a national basis, State-by-State basis, or national and State-by-State basis.

B. The Division has determined there are no high risk categories and will notify SDDOT of the Secretary's determination that the State has been placed in a high risk category in accordance with 23 U.S.C. 106(c) as per Section IX.A.

#### SECTION X. FHWA OVERSIGHT PROGRAM UNDER 23 U.S.C. 106(g)

- A. In 23 U.S.C. 106(g), Congress directs that the Secretary shall establish an oversight program to monitor the effective and efficient use of funds authorized to carry out the FAHP. This program includes FHWA oversight of the State's processes and management practices, including those involved in carrying out the approvals and related responsibilities assumed by the State under 23 U.S.C. 106(c). Congress defines that, at a minimum, the oversight program shall be responsive to all areas relating to financial integrity and project delivery.
- B. The FHWA shall perform annual reviews that address elements of the SDDOT's financial management system in accordance with 23 U.S.C. 106(g)(2)(A). FHWA will periodically review the SDDOT's monitoring of sub-recipients pursuant to 23 U.S.C. 106(g)(4)(B).
- C. The FHWA shall perform annual reviews that address elements of the project delivery systems of the SDDOT, which elements may include one or more activities that are involved in the life cycle of a project from conception to completion of the project. The FHWA will also evaluate the practices of the SDDOT for estimating project costs, awarding contracts, and reducing costs, 23 U.S.C. 106(g)(2) and (3).
- D. To carry out the requirements of 23 U.S.C. 106(g), the FHWA will employ a risk management framework to evaluate financial integrity and project delivery, and balance risk with FHWA and SDDOT staffing resources, available funding, and the State's transportation needs. The FHWA may work collaboratively with the SDDOT to assess the risks inherent with the FAHP and funds management, and how that assessment will be used to align either FHWA or SDDOT resources to develop appropriate risk response strategies.

Techniques the Division and SDDOT may use to identify and analyze risks and develop response strategies include the following:

- Program Assessments;
- FIRE Reviews;
- Program Reviews;
- Certification Reviews;
- Recurring or periodic reviews such as the Compliance Assessment Program (CAP); and
- Inspections of project elements or phases.

These techniques will be carried out in a manner consistent with applicable Division Standard Operating Procedures or other control documents relating to program assessments, FIRE, program reviews, CAP, etc.

Any combination of the following techniques and processes will be used by the Division to carry out the requirements of 23 U.S.C. 106(g):

#### 1. Program Assessments

This technique may take many forms, including joint risk assessments, self-assessment and program assessments. All of these tools are based on the common concepts of identifying strengths, weaknesses and opportunities, and the identification and sharing of 'best' practices to continually improve the program. Program assessments may be triggered by national requirements, national initiatives, or the desire to strive for continual improvement.

#### 2. Program Reviews

Program reviews may be referred to as program improvement reviews, process reviews, program reviews, product evaluations, or continuous process improvement initiatives. A program review is a thorough analysis of key program components and the processes employed by SDDOT in managing the program. Program reviews are often triggered by risk assessments or performance indicators or measures that suggest a need for improvement. Reviews may be initiated by FHWA or SDDOT and may occur at any time during the year, if an immediate need is identified.

The review may be conducted by joint teams from FHWA, SDDOT, and other stakeholder groups or organizations. The review will:

- Ensure compliance with Federal requirements and established procedures and policies;
- Identify opportunities for greater efficiencies and improvements to the program;
- Identify exemplary practices; or
- Identify areas that need attention and make recommendations for improvement.

#### 3. Compliance Assessment Program (CAP) Reviews

The FHWA CAP uses a statistical approach to establish minimum compliance review requirements for Federal-aid highway projects. CAP reviews are one element of a comprehensive and data-driven approach to project oversight. The purpose of the CAP is to provide reasonable assurance, at both the national and local level, that Federal-aid highway construction projects are in compliance with key Federal requirements.

Each April FHWA Headquarters will randomly populate a list of projects from all projects authorized in FMIS for construction within the last year. The Division will conduct the CAP reviews with the assistance of the SDDOT, when necessary. The CAP review results will be evaluated nationally and at the Division level. The CAP review results will assist in identifying compliance issues or trends that need immediate attention, and identifying potential risk areas that could inform our corporate risk assessment and strategic planning process moving forward.

Annually, the Division will share a summary of the CAP evaluation results with the SDDOT. When needed, the Division will work with the SDDOT

in developing a plan to address compliance issues or trends that need immediate attention, or mediate potential risk areas.

#### 4. Risk-based stewardship and oversight of PoDIs and PoCIs:

Annually, FHWA will initiate the process for selection of projects, as shown in Appendix E, that will be administered as FHWA projects of Projects of Corporate Interest (PoCI) or Projects of Division Interest (PoDI) and identify oversight areas for each project for each year in a matrix as shown in Appendix E. The selected PoDI/PoCI projects will have increased oversight and approval authority by FHWA.

All other Federal-aid projects will be delegated to the SDDOT. The delegation of projects to SDDOT does not preclude the FHWA from conducting project level activities as warranted. These projects will be monitored by FHWA through performance measures, program assessments, program oversight, process reviews, or spot checks.

#### E. Program Responsibility Matrix

Appendix C to this S&O Agreement is the Program Responsibility Matrix that identifies all relevant FHWA program actions, and Division and SDDOT program contact offices.

### F. Manuals and Operating Agreements

SDDOT manuals, agreements, and other control documents that have been approved for use on Federal-aid projects are listed in Appendix F to this S&O Agreement.

#### G. Stewardship and Oversight Indicators

The Division and SDDOT may jointly establish Stewardship and Oversight Indicators (Indicators). The Indicators should set targets, track trends, and implement countermeasures and actions when the data is moving away from the desired target direction. Indicators can provide documented evidence that the SDDOT assumption of responsibilities is functioning appropriately. Stewardship and Oversight Indicators should be reviewed on an annual basis. The Stewardship and Oversight Indicators are contained in the Appendix D.

#### SECTION XI. SDDOT OVERSIGHT AND REPORTING REQUIREMENTS

#### A. SDDOT Oversight and Reporting Requirements

Unless FHWA is the identified responsible agency in the executed Agreement or approved PoDI or PoCI plan, the SDDOT is to exercise responsibilities shown to be assigned to the Secretary in compliance with Federal laws, Federal regulations, Federal-aid program requirements, and other mandates or requirements.

The SDDOT is responsible for demonstrating to the FHWA how it is carrying out its responsibilities in accordance with this S&O Agreement. In order to fulfill this responsibility, the SDDOT will comply with all aspects of this Agreement and appendices.

- B. SDDOT Oversight of Locally Administered Projects will be as indicated below unless otherwise required in Federal regulations:
  - B.1. SDDOT is required to provide adequate oversight of sub-recipients including oversight of any assumed responsibilities the SDDOT delegates to a Local Public Agency (LPA).
  - B.2. Pursuant to 23 U.S.C. 106(g)(4), the SDDOT shall be responsible for determining that sub-recipients of Federal-aid funds have adequate project delivery systems for locally administered projects and sufficient accounting controls to properly manage such Federal-aid funds. The SDDOT is also responsible for ensuring compliance with reporting and other requirements applicable to grantees making sub-awards, such as monthly reporting requirements under the Federal Funding Accountability and Transparency Act of 2006, PL 109-282 (as amended by PL 110-252).
  - B.3. The SDDOT acknowledges that it is responsible for sub-recipient awareness of Federal grant requirements, management of grant awards and sub-awards, and is familiar with and comprehends pass through entity responsibilities (2 CFR 200.331 requirements for Pass-thru Entities). The SDDOT shall carry out these responsibilities using the following actions, programs, and processes:

The SDDOT will provide adequate oversight of sub-recipients including oversight of any assumed responsibilities the SDDOT delegates to a LPA. The SDDOT distributes and has oversight over MPO Planning funds allocated to sub-recipients according to 23 CFR 420 and 450, but retains the administration of all components of the LPA construction projects with Federal-aid except Emergency Relief, Right-of-Way (ROW) and Utility certification. The SDDOT enters into an Agreement with the sub-recipient LPA or utilizes a resolution from the LPA for sub-recipient Federal-aid funds.

The SDDOT utilizes the 'Local Roads Plan' as a guide for LPA use. The SDDOT may delegate ROW acquisition to LPAs and does provide the LPA with 'Required forms and Procedures for Acquisition of Right of Way for Federally-Assisted Projects' for their use. For ROW, which is accomplished by LPAs, ROW certification reviews will be accomplished by SDDOT LGA program for all projects to ensure that the Uniform Act requirements are met. SDDOT ROW program will conduct an

annual review of Right-of-Way LPA acquisitions and submit the report to the Division for review.

The SDDOT will provide training to LPAs through formal scheduled training or individual LPA training on the Federal grant requirements and LPA responsibilities, as conditions warrant. The training activities may be accomplished with SDDOT, LTAP, or other specialized staff.

B.4. The SDDOT shall assess whether a sub-recipient has adequate project delivery systems and sufficient accounting controls to properly manage projects, using the following actions, programs, and processes:

The SDDOT will ensure adequate project delivery systems and adequate accounting controls exist by providing procedural or audit reviews on selected LPA project billings.

B.5. The SDDOT shall assess whether a sub-recipient is staffed and equipped to perform work satisfactorily and cost effectively, and that adequate staffing and supervision exists to manage the Federal-aid project(s).

The SDDOT retains the administration of all components of the LPA construction projects with Federal-aid except Emergency Relief, Right-of-Way (ROW) and Utility certification.

B.6. The SDDOT shall assess whether sub-recipient projects receive adequate inspection to ensure they are completed in conformance with approved plans and specifications.

The SDDOT retains the administration of all components of the LPA construction projects with Federal-aid except Emergency Relief, Right-of-Way (ROW) and Utility certification.

- B.7. The SDDOT shall ensure that when LPAs elect to use consultants for construction engineering services, the LPA, as provided under 23 CFR 635.105(b), shall provide a full-time employee of the agency to be in responsible charge of the project.
- B.8. The SDDOT shall ensure that project actions will be administered in accordance with all applicable Federal laws and regulations. The SDDOT will use the following process on required approvals on sub-recipient projects, and approved on sub-recipient administered projects.

SDDOT is permitted to delegate certain activities, under its supervision, to LPAs under Federal regulation 23 CFR 1.11 and 635.105 and SDDOT accepts responsibility for delegated activities. FHWA is required by Federal legislation to conduct

verification activities to assure that SDDOT and the local agencies' implementation of the Federal highway programs conform with laws, regulations and policies. The SDDOT conducts verification activities to assure that local agency Federal-aid projects and programs are implemented in conformance with Federal-aid requirements. The SDDOT retains the administration of all components of the LPA construction projects with Federal-aid except Emergency Relief, Right-of-Way (ROW) and Utility certification.

The SDDOT requires that the following LPA processes are conducted by the LPA or SDDOT staff in accordance with the SDDOT process and procedures:

- a. Consultant selection and management;
- b. Environment;
- c. Design;
- d. Civil Rights;
- e. Financial management, including audits and indirect cost allocation plans;
- f. Right-of-way;
- g. Utility and Railroad certification;
- h. Construction monitoring, including Quality Control/Quality Assurance (QC/QA); and
- i. Contract administration including the SDDOT's responsibility to approve a sub-recipient to pursue a contract procurement method other than competitive bidding.
- B.9. The SDDOT shall document its oversight activities for LPA-administered projects and findings, and how they will share this information with the FHWA.

The SDDOT will resolve all findings from reviews within the agreed upon time.

The SDDOT will review all Metropolitan Planning vouchers for Federal compliance. The SDDOT will submit an annual report from each Metropolitan Planning Organization to the FHWA Division to ensure compliance, per 23 CFR 420 and 23 CFR 450.

#### SECTION XII. IMPLEMENTATION AND AMENDMENTS

- A. This S&O Agreement will take effect as of the effective date of the signature of the FHWA South Dakota Division Administrator, who shall sign this S&O Agreement last.
- B. The Division and SDDOT agree that updates to this Agreement will be considered periodically on a case-by-case basis or when:

- Significant new legislation, Executive orders, or other initiatives affecting the relationship or responsibilities of one or both parties to the S&O Agreement occurs;
- Leadership, or leadership direction, changes at the SDDOT or FHWA; or
- Priorities shift as a result of audits, public perception, or changes in staffing at either the SDDOT or Division Office.
- C. The Division and SDDOT agree that changes may occur to the contents of the Appendices to this S&O Agreement and documents incorporated by reference into the S&O Agreement, except as provided in Section XII.D and E below, and will not require the Division and SDDOT to amend this S&O Agreement. The effective date of any revisions to one of these documents shall be clearly visible in the header of the document. This Agreement and any revised document shall be posted on the Division's S&O Agreement internet site within five business days of the effective date.
- D. Any changes to the high risk categories, Section IX.B, must be documented by an amendment to this S&O Agreement.

### **DOT/FHWA COMMUNICATION PLAN**

South Dakota Department of Transportation (SDDOT) & the South Dakota Division of Federal Highway Administration (FHWA) share a common fundamental goal, which is to provide a safe and efficient transportation system. Both entities have different roles in delivering the transportation system to our customers. The purpose of this document is to improve relationships, product quality, and timeliness of transportation projects by strengthening the communication process.

SDDOT & FHWA jointly agree that in order to continue to provide a quality product, the relationship between both offices must continually improve. Proper and open communication between offices is fundamental to the relationship and trust between entities. Communication and project decisions should be made at the appropriate level. Figure 1 as noted on page 5 of this document is intended to guide each office on the lines of proper communication when utilizing the conflict resolution process.

Conflicting thoughts or ideas are inevitable in transportation delivery, which is why it's critical that each organization adhere to the following rules of communication:

- 1. Early identification and discussion of concerns
- 2. Decisions should be made at the appropriate level
- 3. Document decisions and provide an opportunity for each organization to review
- 4. Be timely with responses
- 5. Respect opinions
- 6. Raise concerns at the appropriate time

Through proper, timely, and respectful communication each organization will improve product delivery resulting in reaching the goal of a safe and efficient transportation system. All members of each organization play a critical role in the success of the transportation system. Through continual improvement of communication, we will ensure our success into the future.

To ensure that both agencies have the most up-to-date information on each other's roles and responsibilities, SDDOT will post the following on its intranet site:

- FHWA's Organizational Chart
- FHWA's Order of Succession
- FHWA's List of Duties

FHWA will post SDDOT's Organizational Chart on its intranet (SDNet) site.


### **FHWA / SDDOT CONFLICT RESOLUTION**

The intent of the Conflict Resolution process is to resolve issues at the lowest level possible.

See Figure 1 for a flowchart of the information below.

- 1. If FHWA and SDDOT staff encounters an issue that they cannot agree on, they shall initiate a face- to-face meeting which includes the appropriate supervisors.
- If the issue cannot be resolved at face-to-face meetings, the parties involved shall document required actions and conditional requirements in writing, along with any supporting documentation. This will help assure that there is no mis-communication as to what is being requested and why.
  - a. If issue is resolved through written correspondence, concurrence shall be sent to the other party in writing or via email.
  - b. If resolution does not occur, staff shall provide the reasons why in writing, including supporting documentation. This again will help assure that there is no mis-communication as to why staff disputes the required actions.
- 3. FHWA and DOT staff shall verbally discuss to attempt to come to consensus on the issue.
- 4. If there is no consensus, FHWA and DOT staff will forward the written correspondence to the DOT Program Manager and FHWA Team Leader for their review and concurrence.
- 5. DOT Program Manager and FHWA Team Leader will review written documentation.
  - a. If the Program Manager and Team Leader concur with required actions, concurrence shall be sent to FHWA and DOT staff in writing or via email.
  - b. If the Program Manager and Team Leader do not concur, they shall arrange a meeting with the originators of the dispute to attempt to come to consensus on the issue.
    - i. If there is consensus on the issue, consensus shall be thoroughly documented for file.
    - ii. If there is no consensus on the issue, the Program Manager and Team Leader will forward all written documentation to the Division Director (DD) and the FHWA Assistant Division Administrator (ADA) for review.
- 6. The DD and the ADA will review the written documentation and meet with the appropriate DOT and FHWA staff.
  - a. If DD and ADA concur, concurrence shall be sent to FHWA and DOT staff in writing or via email.
  - b. If DD and ADA do not concur, they shall arrange a meeting with the DOT Program Manager and FHWA Team Leader and the originators of the dispute to attempt to come to consensus on the issue.
    - i. If there is consensus on the issue, consensus shall be thoroughly documented for file.

- ii. If there is no consensus on the issue, the DD and ADA will forward all written documentation to the Department Secretary and the Division Administrator (DA) for review.
- 7. The Department Secretary and the DA will review the written documentation and meet with the DD, ADA, DOT Program Manager, FHWA Team Leader, and the originators of the dispute.
  - a. If the Department Secretary and the DA concur, concurrence shall be sent to FHWA and DOT staff in writing or via email.
  - b. If Department Secretary and DA do not concur, the Department Secretary shall arrange a meeting with the DA, DD, ADA, DOT Program Manager, FHWA Team Leader, and the originators of the dispute to attempt to come to consensus on the issue.
    - i. If there is consensus on the issue, consensus shall be thoroughly documented for file.
    - ii. If there is no consensus on the issue, the Department Secretary and DA will determine next course of action.



# APPENDIX B PROJECT ACTION RESPONSIBILITY MATRIX (As of February 6, 2015)

The following matrix identifies Federal-aid highway program (FAHP) project approvals and related responsibilities. The matrix specifies which ones are subject to State assumption under the provisions of 23 U.S.C. 106(c) or other statutory or regulatory authority, as well as those which are reserved to FHWA.

Except as expressly stated in notes to the matrix below, the State cannot assume any item marked only as "FHWA" in either column. Any item marked only "FHWA" is reserved to FHWA because it is outside the the scope of 23 U.S.C. 106(c), or otherwise is reserved to FHWA by law. The State DOT is responsible for ensuring all individual elements of the project are eligible for FAHP funding, but all final eligibility and participation determinations are retained by FHWA. While FHWA may not delegate decision-making authority to a State unless authorized by law, FHWA may authorize a State DOT to perform work needed to reach the decision point, or to implement the decision.

The State DOT is responsible for ensuring all individual elements of the project are eligible for FAHP funding but all final eligibility and participation determinations are retained by FHWA.

Any changes to the Project Action Responsibility Matrix must be approved by the FHWA Office of Infrastructure in writing and documented by an amendment to this S&O Agreement.

# **PoDi/PoCI Project Selection Process:**

Annually, the Division will review the program of scheduled projects to determine which projects will be administered as FHWA projects of Projects of Corporate Interest (PoCI) or Projects of Division Interest (PoDI). PoDIs and PoCIs may be either SDDOT or LPA administered projects. As explained in Section III of the Stewardship Agreement, PoDI and PoCI projects are not high risk categories. A PoCI may include Major Projects >\$500 million, Executive Order Projects, TIGER projects, Projects of National and Regional Significance and Other Division Office/HQ Significant Projects. PoDIs are similar in nature to projects previously designated as full oversight projects. However, PoDIs are selected via a risk-based process and may be selected for one or more risk-based project feature, activity, or phase of interest. FHWA will initiate this action by providing a list of suggested PoDI/PoCI projects and identify oversight areas for each project for each year in the 'Projects' tab of this appendix. Projects shall be considered for the PoDI/PoCI list prior to preliminary engineering (PE) or contract authorization. PoDI/PoCI projects will be identified based on one or more of the following criteria: Complexity, Cost, Schedule, urgency, Environmental Considerations/Stakeholers, Funding, Project Administration, National/Regional Significance, Corporate Action, or Local Considerations.

In June through July of each year, FHWA will review the list of upcoming Federal projects and select PoDI/PoCI projects, identify activities or phases of projects for Federal oversight. The list will be shared with SDDOT between August and September.

# **Appendix G: Glossary**

<u>Assumption of Responsibilities</u> – The act of State DOT to accept responsibility for carrying out and approving certain actions in the place of the FHWA. Such actions are to be taken by the State DOT in conformance with Federal laws, regulations, and policies.

<u>Assumed Projects</u> – Federal projects that the State DOT reviews in the place of the FHWA and has the authority to approve certain specified actions pertaining to design; plans, specifications, and estimates; contract awards; and inspections.

<u>Certification Reviews</u> – A review that formalizes the continuing oversight and day-to-day evaluation of the planning process.

<u>Compliance Assessment Program (CAP) Reviews</u> – A statistical approach to establish minimum compliance review requirements for Federal-aid highway projects. CAP reviews are one element of a comprehensive and data-driven approach to project oversight. The purpose of the CAP is to provide reasonable assurance, at both the national and local level, that Federal-aid highway construction projects are in compliance with key Federal requirements.

<u>Control Document</u> – Applicable laws, regulations, standards, policies, and standard specifications approved by FHWA for use on Federal-aid highway projects.

<u>Core Functions</u> – Activities that make up the primary elements of the division office's Federalaid oversight responsibilities based on regulations and national policies. Core functions in the division office are Planning, Environment, Right-of-Way, Design, Construction, Finance, Operations, System Preservation, Safety, and Civil Rights.

<u>Locally Administered Projects</u> – For the purpose of the S&O Agreement, a Federal-aid project in which an entity other than a traditional State DOT is a sub-recipient and this entity is administering the particular phase being authorized, i.e., Preliminary Engineering, ROW, or Construction. These would include projects where the non-traditional entity will either perform the work itself or enter into a contract for services or construction. State DOT remains responsible for the local public agency's compliance on locally administered projects.

<u>Local Public Agency (LPA)</u> – Any organization, other than a traditional State DOT, with administrative or functional responsibilities that are directly or indirectly affiliated with a governmental body of any Tribal Nation, State, or local jurisdiction. LPAs would most often include cities or counties. However, an LPA, as defined here, could also include a State entity as well, perhaps even a part of a State DOT. An example could include a Port Authority or Toll Authority that had not traditionally worked with the Federal-aid highway program (FAHP).

Oversight – The act of ensuring that the FAHP is delivered consistent with laws, regulations, and policies.

<u>Program Assessments</u> – This evaluation technique may take many forms, including joint risk assessments and self-assessments. These tools are based on the common concepts of identifying

strengths, weaknesses, and opportunities and the identification and sharing of "best" practices to continually improve the program.

<u>Program Reviews</u> – A thorough analysis of key program components and the processes employed by the State DOT in managing the program. The reviews are conducted to: 1) ensure compliance with Federal requirements; 2) identify areas in need of improvement; 3) identify opportunities for greater efficiencies and cost improvement to the program; and/or 4) identify exemplary practices.

<u>Projects of Division Interest (PoDIs)</u> – PoDIs are those projects that have an elevated risk, contain elements of higher risk, or present a meaningful opportunity for FHWA involvement to enhance meeting project objectives.

For PoDIs, FHWA has made a risk-based decision to retain project approval actions or conduct stewardship and oversight activities for the project as provided for in 23 USC 106.

<u>Recurring Reviews</u> – Reviews that the division office conducts annually or on a regular periodic basis. Examples include NBIS, HPMS, HVUT, etc.

<u>Risk Assessment</u> – The process of identifying a risk event, determining the likelihood of the event happening, determining the impact (positive or negative) of the event on the delivery of the FAHP, and identifying an appropriate risk response strategy.

<u>Risk-Based Approach</u> – Incorporating risk assessment and risk management into investment and strategic decision making (the means by which limited resources are focused).

<u>Risk Management</u> – The systematic identification, assessment, planning, and management of threats and opportunities faced by FHWA projects and programs.

<u>Stewardship</u> – The efficient and effective management of the public funds that have been entrusted to the FHWA.

<u>Unit Performance Plan</u> – The annual performance plan prepared by an individual FHWA unit that address unit responsibilities and priorities taking into account the National Performance Objectives and National Initiatives identified in the FHWA's Strategic Implementation Plan (SIP) as well as specific initiatives identified at the unit level based on risk.

## **Appendix H:**

**Project Oversight Designation Requirement in the Fiscal Management Information System** (FMIS)

**PoDI/State Administered** – Projects of Division Interest that are administered by the State DOT. If specific 106(c) responsibilities are assumed by the State DOT, the responsibilities assumed should be noted in the project description and/or remarks fields. (Projects where all six 106(c) responsibilities are retained by FHWA would need no such notation.) These are projects where FHWA will review and approve actions pertaining to one or more of the following (design; plans, specifications, and estimates; contract awards; and project inspections) and may also include additional areas of focus by the division.

**PoDI/Locally Administered** – Projects of Division Interest that are locally administered. If specific 106(c) responsibilities are assumed by the State DOT, the responsibilities assumed should be noted in the project description and/or remarks fields. (Projects where all six 106(c) responsibilities are retained by FHWA would need no such notation.) These are projects where FHWA will review and approve actions pertaining to one or more of the following (design; plans, specifications, and estimates; contract awards; and project inspections) and may also include additional areas of focus by the division.

**Assumed/State Administered** – Projects where *responsibility for all six Section 106(c) items* is assumed by the State DOT and the project is administered by the State DOT. These are projects where the State DOT has assumed responsibility for review and approval actions pertaining to all of the following: design; plans, specifications, and estimates; contract awards; and project inspections.

**Assumed/Locally Administered** - Projects where *responsibility for all Section 106(c) items* is assumed by the State DOT and the project is administered by a local agency. These are projects where the State DOT has assumed responsibility for review and approval actions pertaining to all of the following: design; plans, specifications, and estimates; contract awards; and project inspections.

**Other** – There may be situations that do not fit the previous categories. In cases where the project is identified as "Other," additional details should be provided in the project description and/or remarks fields. Examples could include non-State DOT direct recipients.
