



I-35 in Georgetown reopens after deadly crash



GEORGETOWN, Texas (KXAN) — A crash on Interstate 35 in Georgetown killed a 30-year-old man early Wednesday morning. The wreck shut down part of the highway north of State Highway 29 for three hours.

Police and fire crews responded to the emergency calls around 4 a.m. after a 1999 Chevrolet Tahoe veered off the main lanes and into a grass median, hit a guardrail and flipped several times. It finally landed upside down on the guardrail over the North San Gabriel River. Georgetown Fire Department crews managed to hook the SUV to the front of one of their engines to keep it from falling into the river.

No other cars were involved in the crash. The SUV has since been towed, and officers reopened all the lanes of I-35.

Police identified the man as Ricardo Miranda Jr., of Seguin. He was the only person in the SUV. They believe alcohol may have been a factor, but they are waiting for a definitive answer on that from the Medical Examiner's Office.
