Background:

The initial challenge of the Every Day Counts (EDC) initiative was to accelerate the deployment of ten (10) proven but not widely implemented innovative strategies and five (5) technologies that are aimed at shortening project delivery and enhancing project performance. EDC is about pursuing better, faster, and smarter ways of doing business. Beyond the deployment of the initial 10 strategies and 5 technologies, the STIC will serve as forum for considering the rapid deployment of other innovative strategies and technologies in the future.

Team Member Responsibilities:

- Provide input on the initiatives to be pursued,
- Establish performance goals to measure success,
- Administer the STIC Incentive Program,
- Provide outreach to others (e.g. constituents, peers, other agencies, etc.) to gather input and assist with implementation of initiatives, and
- Render STIC decisions by the consensus of all participating members subject to the concurrence of the CTDOT and FHWA co-facilitators.


Approach: The STIC will meet 3 – 4 times a year either in Newington, CT or Glastonbury, CT.

Resources:


Staff support for the STIC will be provided by the Federal Highway Administration Connecticut Division’s Assistant Division Administrator.
