## Background

In 2009, the Federal Highway Administration (FHWA) launched Every Day Counts (EDC) in cooperation with the American Association of State and Highway and Transportation Officials (AASHTO) to speed up the delivery of highway projects and to address the challenges presented by limited budgets. EDC is a state-based model to identify and rapidly deploy proven but underutilized innovations to shorten the project delivery process, enhance roadway safety, reduce congestion and improve environmental sustainability. With programs like the EDC initiative, Second Strategic Highway Research Program (SHRP2), and other innovation deployment programs as the driving force nationally, the need for every State to have an innovation deployment council or similar group is essential to ensure that the innovation deployment remains a State-based initiative. FHWA's State Transportation Innovation Council (STIC) Incentive Program and the Demonstration Project Program will help States institutionalize innovations and meet their innovation deployment goals.

## **Team Member Responsibilities**

Provide input on the initiatives to be pursued, appoint agency and industry representatives to the implementation teams, and establish performance goals to measure success. Render STIC decisions by the consensus of all members present at each scheduled meeting subject to the concurrence of the DDOT and FHWA STIC co-chairs.

## Approach

The STIC will convene an annual forum to identify past EDC successes/processes and potential innovations.

#### Resources

Staff support for the STIC will be provided by DDOT and FHWA Division subject matter experts assigned to lead efforts in the EDC Implementation Plan(s). Funding for travel for the STIC and the implementation teams may be available from FHWA.

#### **Time Frames**

The STIC will be an on-going team and will only be disbanded upon agreement of the two STIC co-chairs.
