The focus is on innovative strategies to accelerate transportation project delivery and technologies proven to enhance project quality and effectiveness.

## Background:

The initial challenge of the Every Day Counts (EDC) initiative was to accelerate the deployment of 10 proven but not widely implemented innovative strategies and 5 technologies that are aimed at shortening project delivery and enhancing project performance. EDC is about pursuing better, faster, and smarter ways of doing business. The STIC will serve as the forum for considering the rapid deployment of other innovative strategies and technologies in the future.

## Team Member Responsibilities:

- Provide input on the initiatives to be pursued,
- Establish performance goals to measure success,
- Administer the STIC Incentive Program,
- Provide outreach to others (e.g. constituents, peers, other agencies, etc.) to gather input and assist with implementation of initiatives, and
- Render STIC decisions by the consensus of all participating members subject to the concurrence of the MaineDOT and FHWA co-facilitators.

## Approach:


The STIC will meet 3 – 4 times per year in Augusta, Maine.

## Resources:


Staff support for the STIC will be provided by the Federal Highway Administration Maine Division Administrative Assistant.


