- (1) Travel for the rural minor collector and rural/urban local functional systems is estimated by the States based on a model or other means and provided to the FHWA on a summary basis. Travel for all other systems are estimated from State-provided data in the Highway Performance Monitoring System. Fatality data obtained from the Fatality Analysis Reporting System, National Highway Traffic Safety Administration. Does not include unknown fatalities.
