(4) Prior to 1995, Reconstruction was not split into separate items for added capacity and no added capacity. When Pre-1995 projects are reopened, the improvement type has been recorded, causing negative adjustments to "Pre-FY 1995 Reconstruction" and positive adjustments to the two new Reconstruction items.
(5) These amounts represent adjustments of certain prior year obligations.
