PEER OF THE YEAR

Chatham County Department of Engineering Mr. William (Billy) Gordon

This award recognizes Mr. William Gordon of the Chatham County, Georgia, Department of Engineering for his expertise and a life-time commitment to the right-of-way acquisition field. Mr. Gordon has served as the day-to-day manager of all right-of-way acquisitions for the Chatham County Road and Drainage Improvement Program for 23 years. He is responsible for the acquisition of over 3,000 parcels from 200 different projects, having value over \$100 million. Many of these projects involved the use of Federal funding, were complex and included the relocation of displacees and condemnations cases.

Mr. Gordon's experience is varied and wide-ranging. He has provided Chatham County with comprehensive project management which entailed being responsibility for many aspects of the right-of-way program area. He comes from a family of former Georgia Department of Transportation right-of-way professionals who provided him with a solid background in the fundamentals of right-of-way acquisition early in his career.

Mr. Gordon has been the go-to person in Chatham County for all things right-of-way related. His colleagues point out that he can remember people and details of projects back to the beginning of his career. One colleague notes that "Billy has repeatedly exhibited the patience and persistence necessary to achieve successful results, while treating each owner as a real person, not a file number." Mr. Gordon will retire in Spring 2017 and his colleagues state that he will be greatly missed.

Real Estate Automated Data System
(READS) Bureau and Regional Team for its
persistent and detailed work involving
creative problem solving in developing the
READS system. This system was developed
to harness and implement technology which
improves the efficiency of the agency's
right-of-way program. READS is a
collaboration effort between the WisDOT's
real estate business experts, the information
technology staff and BEM Systems, Inc.

The user-friendly system in place today, which WisDOT and consultant staff members use on all WisDOT real estate projects, has a variety of features that improve WisDOT's right-of-way program, including:

- Being linked to WisDOT's financial system, right-of-way plat document management system, legal description system, and geographic information system, which provides record storage and record retrieval for projects;
- Using sophisticated barcode scanning that automatically saves copies of every document the system generates in its own self-contained document management system;
- Supporting two levels of electronic signatures and utilizes a powerful custom reporting tool which allows user to build their own unique reports and save them in their own report library; and
- Supporting staff assignments to specific projects and parcels, while integrating the functions of residential and business relocation, property management, lease management, and local public agency coordination.

Delaware Department of Transportation Right-of-Way Section Embracing Change in the Delaware DOT Right-of-Way Section



DelDOT ROW Section

The Delaware Department of Transportation (DelDOT) encountered difficult operating challenges for several years. The DelDOT Right-of-Way (ROW) section addressed the situation and strived to reinvent itself into a proactive and vibrant organization. The entire team of management and staff have joined together to develop and deploy a new organizational structure with major personnel changes. They utilized innovative training and new streamlined processes that have led to a dramatic increase in efficiency.

The DelDOT ROW team's effort to embrace change has recently helped it to achieve several significant milestones including:

- Acquisition of the right-of-way needed for DelDOT to achieve its highest Capital Road Project delivery in the past 15 years;
- A 10-fold increase in the disposal of excess land;
- A complete rewrite of the ROW Manual;
- The awarding of the state's first Diverging Diamond interchange; and
- The successful completion of the second largest ROW project in DelDOT history.

Without the commitment and dedication to embrace change from all ROW staff, these successes would not have been possible.

STEWARDSHIP AWARD

Kansas Department of Transportation Kansas DOT Bureau of Local Projects Local Public Agencies Right-of-Way Online Training

In Kansas, Local Public Agencies (LPAs) self-certify that they have complied with the Uniform Act in the acquisition of properties for their projects. To insure compliance, the Kansas Department of Transportation (KDOT) has annually traveled the state to provide training to LPAs and their consultants, and review project right-of-way files. Training attendance has been voluntary, and in the past, attendance has sometimes been low due to the travel and time required to participate.

In order to provide training to LPAs more efficiently, KDOT partnered with the Kansas Local Technical Assistance Program (LTAP) center to develop a certification process and web-based training for LPAs. The new training will replace KDOT and FHWA as partners traveling the state to provide in-person training—a practice that was proving to be expensive and time consuming for all involved.

This new training and certification process will be mandatory for LPAs and their consultants. At the end, participants will be required to take and pass a test with questions that KDOT created. KDOT believes this program will not only be a more cost and time effective method of providing this important training, but also result in better participation rates given the certification component.

STREAMLINING AND INTEGRATION AWARD

Missouri Department of Transportation Missouri DOT Southwest District Rogersville Design Build/Right-of-Way Team

Farm Road 253 in Rogersville, Missouri had been experiencing an increase in accidents, and traffic was predicted to double over the next 20 years. These circumstances created a need to convert a portion of the expressway into a freeway and improve safety by replacing signalized intersections with controlled access. Work on the Rogersville Design-Build Project, which began September 15, 2014, greatly improved traffic flow and safety.

Innovative methods were employed by the Missouri Department of Transportation (MoDOT) while designing, acquiring right-of-way, and constructing the roadway simultaneously. The Rogersville Design Build Project developed and met several goals in

order to create an innovative way to work on this project while satisfying the needs of the customers. An aggressive acquisition schedule was established and a new acquisition model was created. In the end, MoDOT was able to limit right-of-way acquisition and thus add over \$3 million in additional improvements to the project to address a "wish list" of items in coordination with the City and County Commissions.

Mississippi Department of Transportation Mississippi DOT Right-of-Way Division and Information Systems Division Parcel Tracking System

Mississippi Department of Transportation (MDOT) Parcel Tracking System (PTS) is an innovative project management software program built inhouse through coordinated efforts of the MDOT Right-of-Way Division and the Information Systems Division. The PTS is a one-stop-shop system which allows tracking, updating, and managing all facets of the right-of-way process including personnel assignments from the inception of a project to the issuance of the right-of-way certificate. The PTS includes other modern capabilities such as document storage and retrieval, electronic signature and mobile uploading.

The user-friendly PTS helps the Right-of-Way

Division better track its processes to ensure accurate and timely project delivery while providing accountability in reporting historical data and serving as a centralized file storage and document retrieval system. Among numerous other features, the PTS provides for:

- The automatic creation of right-of-way projects and population of project information from another internal system;
- An automatic parcel numbering system to create parcels and link associated parcels; and
- The recording of right-of-way project cost estimates and tracking of actual expenditures against estimated expenditures.
