- PMF will open 9/03/2024 for State DOTs to submit their reports by 10/01/2024.
- This year, State DOTs will submit one report:
  - Mid Performance Period (MPP) Progress Report in the PMF for the pavement, bridge, highway reliability, freight, traffic congestion, and emissions measures

### Roles & Responsibilities: State DOT

- Identify available/needed data.
- Provide discussions of performance, progress, and investments.
- Provide discussion of how targets support long-term national goals and the relationship to other performance expectations.
- Collect and submit required data and reports.
- Document extenuating circumstances if applicable.
- Work with Division Offices to ensure accurate, complete, and timely submittal of the PMF.
- Submit Mid Performance Period Progress Report (MPP) on or before October 1, 2024.
